OVERVIEW

On 19 July 2021 England moved to Step 4 of the roadmap. This marks a new phase in the government's response to the pandemic, moving away from stringent restrictions on everyone's day-to-day lives, towards advising people on how to protect themselves and others, alongside targeted interventions to reduce risk.

As COVID-19 becomes a virus that we learn to live with, the government's view is that there is now an imperative to reduce the disruption to children and young people's education - particularly given that the direct clinical risks to children are extremely low, and every adult will have been offered a first vaccine and the opportunity for two doses by mid-September. The Department for Education's priority, shared by St Mary's, is to deliver face-to-face, high-quality education to pupils. The government reports that the evidence is clear that being out of education causes significant harm to educational attainment, life chances and mental and physical health.

All that said, incidence of the virus in society remains high although the statistics indicate that there is significantly less risk of serious illness and hospitalisation. The school's approach is to continue to follow government guidance which asks us all to be cautious. This risk assessment and the consequent operation of the school will reflect government guidance whilst simultaneously being ready to adapt to changes in the local (https://www.berkshirepublichealth.co.uk/covid-19-dashboard/?view=cases&location=Windsor%20and%20Maidenhead) and national picture.

RISK ASSESSMENT

The start of the Michaelmas term 2021 represented a major step towards a return of the operation of the school to pre-COVID routines. It is the school's view that, given the virulence of the Delta variant and the consequent significant presence of the virus in society, it is not yet possible to 'switch off' all COVID measures. However, these concerns must be balanced with the reduced numbers of individuals becoming seriously ill, those requiring hospitalisation and, importantly, the reduced numbers of fatalities.

The purpose of this risk assessment is to set out how the school is organised and run during the Michaelmas term 2021. It remains a live document and continues to be updated and changed as further guidance is received and as the national and local picture develops. The school will continue to consult with staff and take staff views into account in future iterations of the risk assessment.

KEY MESSAGES – from September 2021 (Updated 5 January 2022)

- The school operates in line with government guidance **Schools COVID-19 operational guidance** (Reference A).
- Pupils are no longer be in 'bubbles' and mixing across year groups is permitted.
- The school is no longer be zoned. Pupils may now move to departments for lessons and not remain in year group zones.
- The Staff Refectory and the Pupil Refectory have reverted to normal operations.
- Social distancing is no longer required by staff or pupils.
- High levels of personal hygiene continue to be encouraged.
- Additional sanitising measures continue to be taken across the school site.
- An outbreak management plan (OMP) sets out how the school will operate should there be an outbreak in the local area or in the school.
- Pupils continue to be tested twice a week in the Asymptomatic Test Site (marquee). Staff are encouraged to use school provided home test kits twice a week.
- Staff and pupils are encouraged to keep all school spaces well ventilated at all times.

UPDATES (added to Risk Assessment to reflect changes in the COVID threat and control measures - latest changes in purple font)

As at **Monday 8 November**, as a result in an increase in positive cases in the school detected by our LFT programme and confirmed by NHS PCR tests, the school has increased the number of COVID secure measures in place with the aim of reducing the number of positives in line with the school's outbreak management plan. The additional measures can be summarised as follows:

- Year 7 to wear masks in the corridors.
- Year 7 will eat in a special designated area of the refectory this week.
- Year 7 will have morning prayers in the Rose Theatre rather than in the Chapel with the whole school.
- For House meetings (Tuesday 9 November 2021), please could tutors maintain a social distance between Year 7 girls and the rest of the House.
- All classroom teachers of Year 7 are encouraged to maintain social distancing as much as possible and keep classrooms well ventilated whilst being mindful of the need for pupils to be comfortable. We ask that the residential staff encourage the girls to wear their fleeces and school scarves if they wish.
- If a member of staff would like a screen for their classroom they have been invited to contact the Estates Department (as at 10/11/21 approximately 9 screens have been distributed).
- Year 7 will no longer take part in the House Dance competition in order to limit interaction between that year group and others.
- Staff leading committee meetings this week may wish to rearrange their venues so that there is more space available.
- Paused whole school singing in Chapel.
- We will undertake daily lateral flow testing of all the pupils from Monday through to Thursday week beginning 8 November in order to identify any further cases and limit the spread of the virus.

On **Tuesday 9 November** these measures were reviewed again following a further increase in positive cases on Sunday 7 November and the following additional measures were put in place.

- All girls and staff to wear face coverings in the corridors. *
- Morning Chapel until Friday 19 November to be in satellite locations with only one year group in chapel. *
- Postpone House Dance competition (due 12 November 2021) and will look for an alternative date later in the term.
- U6 parent talk switched to Rose Theatre for increased space and ventilation.
- U6 parent meeting set up in OC designed to maximise social distancing.
- All parents required to take a LFT prior to visiting school.
- Staff and pupils to be encouraged to keep left in corridors (dots and signage to be put in place).
- Staff encouraged to keep doing the home testing twice per week test kits available at the weekly staff meeting.

On **Wednesday 10 November** 12 pupils tested positive in the school's ATS bringing the total in the school community to approximately 50. Following consultation with the school doctor, the local area health protection team and the Chair of Governors it was decided to send the pupils home that afternoon/evening for an extended exeat Page 5

weekend (school lessons to carry on as normal remotely) and thereby creating a five day 'circuit break'. All pupils to show evidence of a negative LFT before coming back into school on Monday 15 November. Routine testing to take place during that week - 100% of pupils on Tuesday 16 and Friday 19 November as well as daily testing for close contacts. There were no positive results and when 100% testing of pupils on Monday 22 November was also negative, the school reviewed the additional control measures in place. On **Tuesday 23 November** the additional measures marked * in the list above were withdrawn.

On **Monday 29 November**, following new guidance from the Department for Education (see References A and I) the school reintroduced the wearing of face coverings in circulation spaces. The school also noted the change in arrangements should a pupil or member of staff be identified as positive with the new Omicron variant – specifically, close contacts would need to go home and self-isolate. The school has reviewed the programme of activities and events for the last 2 weeks of term but felt that the programme could largely go ahead as planned. Carols in the Link were moved to the sports hall allowing year groups to be separated and maximum ventilation.

On **Friday 17 December** (after the end of term and with only support staff on the school site) two senior members of Housekeeping tested positive. Housekeeping staff, less the Housekeeper, sent home early for the Christmas break to minimise the risk of further transmission within the department and to other departments. Other measures introduced for support staff working during the week beginning 20 December included:

- Face coverings to be used throughout the school site where two people or more are gathered unless outside.
- No 'social use' of the staff refectory.
- Estates department to stagger breaks.
- Lunch in pupil refectory socially distanced one person per table.
- Christmas gathering on 23 December cancelled.

Return to school for Lent term 2022 – changes in place for **Sunday 9 January 2022**. Following new Government guidance issued as a result of the Omicron variant, St Mary's has updated the whole school risk assessment with these new control measures:
